The 2019-2020 Depository and Investment Resolution #2019-7 was discussed by Member Groh, stating Michigan Class sub funds accounts were new to the resolution this year. Member Droscha motioned for approval and was seconded by Member Malcangi. Vote: Ayes: Ayres, Droscha, Groh, Malcangi, and Silsby. Nays: None. Resolution declared adopted.

## **Board Reports**

Supervisor Silsby had an email from Mason Baseball Association to check baseball dates with the hall/pavilion rental dates.

Clerk Ayres reported already receiving many absentee voter ballots for May election. She also shared a communication from Par Plan requesting a representative be chosen by resolution from each municipality as the main contact person with PAR Plan. No board members were interested in the position and the Supervisor and Clerk already meet with the PAR Plan Agent. This may be discussed in the future.

Treasurer Groh reported Parks and Recreation Plan would be ready for a public hearing after the meeting at the end of the week. Groh asked if there was a possibility to pick up picnic tables from Droscha farm. Member Droscha said to call anytime. Groh gave the cash report as \$768,429.59 and the Quarterly Investment Report as \$543,850.98.
