Old survey in Clerk's records from Wolverine was shared with board. Member Anderson has left a message with Wolverine to get bid for new survey.

Correspondence was reviewed from City of Mason fire runs, Comcast notice to renew Metro Act contract at the time of expiration, and Hamlin Township Master Plan hearing.

Supervisor gave update on solar field and cemetery, including gravel for Fowler Cemetery.

Clerk provided balance sheet and discussed changes to election law requiring nine days of early voting and the need for an additional tabulator or contracting with City of Mason to share election duties. Motion made by Member Waltz and seconded by Member Waltz to order new tabulator for approximately \$6,000. Vote: Ayes: Anderson, Ayres, Droscha, Malcangi and Waltz. Nays: None. Absent: None. Motion carried.

Treasurer gave the cash report.

Trustee Malcangi reported property behind Columbia Creek Park has no trespassing signs posted. He also discussed soil being removed from solar field. Service recognitions from previous board decision were discussed and will be addressed.
