# **MINUTES**

The Aurelius Township Board met in regular remotion session on Tuesday, December 8, 2020, through TEAMS software.

## **Unfinished Business**

Attorney Koches advised discussing with inspector and having him agree in writing to expectations and if inspector will not sign then take the next step. Member Silsby will speak with Inspector about list to see if inspections were completed.

Member Groh motioned to have Silsby and Rakich meet with Inspector requiring inspections be completed within next 33 days and put it in writing and have Inspector sign it. Member Groh asked for a Building Program Reorganization update. Member Silsby stated it was reorganized. Groh stated board has not seen anything in writing and a

Assessing Quarterly report was received from Josh Simmons, Assistant Assessor. Assessing office is working on New Building inspections and equalization ratios have been received from Ingham County. Simmons will work on poverty exemption resolution with Clerk. Written report attached.
