VI. HOMEOWNER AFFIDAVIT

I hereby certify the mechanical work described on this permit application shall be installed **by myself in my own home** in which I am living or about to occupy. All work shall be installed in accordance with the Mechanical Code and **shall not be enclosed, covered up,** or put into operation until it has been **inspected and approved** by the Township Mechanical Inspector. I will cooperate with the Inspector and assume the responsibility to arrange for necessary inspections.

VII. PLAN REVIEW REQUIREMENTS

Plans are required for all building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act No. 229 of the Public Acts of 1980, as amended, and shall bear that architect's or engineer's signature and seal, except:

- One and two-family dwellings when the total building heating/cooling system input rating is 375,000 Btu's or less.
- Alterations and repair work determined by the mechanical official to be of a minor nature.
- Business, mercantile, and storage buildings having HVAC equipment only, with one fire area and not more than 3,500 square feet.
- Work completed by a governmental subdivision or state agency costing less than \$15,000.00

PLANS MUST BE SUBMITTED BEFORE A PERMIT CAN BE ISSUED.

VIII. FEE CLARIFICATIONS

ITEM # 2, RESIDENTIAL HEATING SYSTEM:

This item is used for the installation of a heating system in a new residential structure. Item # 10; Gas Piping and # 18; Duct, **SHOULD NOT BE** charged. Replacement systems should be itemized.

X. INSTRUCTIONS FOR COMPLETING APPLICATION

GENERAL: Mechanical work shall not be started until the application for permit has been filed with Aurelius Township. All installation shall be in conformance with the Mechanical Code. No work shall be concealed until it has been inspected. When ready for an inspection, call the Township Office 517-628-2093 providing as much advance notice as possible. The Township inspector will need the location and permit number.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A PERMIT WILL BE CANCELED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELED PERMITS CANNOT BE REINSTATED.
